## **2020-21 Overview**

Encore Learning is pleased to share the Annual Report for the year from July 1, 2020 - June 30, 2021.

During this year Encore Learning's activities were entirely virtual.

With more than 1,000 members, 60 courses, 45 Special Events, 9 Clubs, 55 instructors, and 130 volunteers the organization continued to grow during this 18th year.

The quality of our courses stands strong. Member evaluations show

- Average instructor rating of "Outstanding"
- 91% would recommend the course to another member.

Our members are actively engaged - 94% took at least one course.

As a 501(c)(3) nonprofit organization membership dues and donations are tax deductible as a charitable contribution. The board and staff work diligently to ensure cost-effective delivery of courses and programs. Gifts from members and donors ensure our sustainability and enable us to support various scholarship funds.



## Membership

Encore Learning is a membership organization. Their volunteer efforts and leadership create the high-quality programming. Members stay with us, 240 members have been an Encore Learning member for more than 10 years. Given so many members have longevity in their engagement with us, perhaps Encore Learning not only improves their quality of life but keeps them living longer!

Membership did decline slightly during the year, no doubt because adult learners are tired of being on their devices and are eager to be in person.

Note: Fall 2020 had five courses cancelled. Spring 2021 had two courses cancelled.




## **Special Events**
